Chair Report

- Conversation with the area biologist have hired a new person to run the municipal shellfish program. She has a background in aquaculture.
- Clammers are encouraged to communicate their concerns to the state

Warden Report - Shellfish Warden did not submit a report

Conservation Events

- Re-seeding
 - Billy Gove expressed concerns that after reseeding the clammers aren't able to check on the results.
 - Owners not permitting people to go down their driveways even to check the flats.
 - Suggest making this process more systematic with scheduled visits to see about success of reseeding
 - Access is the problem for a lot of sites. Need to get a canoe or row boat
 - Netting may help. Green crabs penetrate most netting.
 - Concentrating clams in square meters may be more attractive to green crabs
 - The area biologists survey sites afterward to see if the clams have survived.
 - Brian surveys areas
 - Suggest seeding closed areas so that there is a better chance for survival.
 - The committee can close areas.
 - Might practice rotating closures where reseeding

- Inner Harbor is closed right now and is split between the two towns
- Webb Cove
- Some locations have been dug very hard this year. The flats may not recover quickly.
- Need to obtain permits to dig, transport and plant seeds.
- Alvah moves to seed inner harbor. Seconded. Approved by the committee.
 - Suggest that a smaller contingent load canoes.
 - Can paddle from Merchant Point
 - Need to have the permits in advance.
 - Recommend waiting until April when the weather has warmed a little.
 - If nets are used, you need to schedule pulling up the nets in the fall.
- Cleanup Days
 - Webbs Cove landing available to clammers approved by the committee
 - Spofford's Cove
 - Plumb Point
 - Cat's Cove
- Brushing
- Green crab intervention picking them up on the shore. Timing is difficult.
 Volunteers want to earn credits in April and green crab intervention is better in the summer.
- Building relations with property owners
 - Most clammers follow the rules.
 - · A few bad clammers irritate the property owners

Other business

- George wants to step down as the chair
 - Town Report needs to indicate work done in Deer Isle and Stonington
- Question: Has there been any change in policy about seaweed harvesting?
 - Property owners have challenged access to the intertidal zone may be applicable for seaweed harvest.
 - Clams fall under the Fishing, Fouling and Navigation law.
