Minutes from May 1, 2023-Motion by John 2nd by Donna to approve. 5-0

Weekly Warrants-Motion by John, 2nd by Donna to approve them. 5-0

- 1. School building generator quote-TM passed out prices from CL Haskell for generator quote for \$28, 872. Includes wiring, switch, delivery, pad for 38KW propane generator. Board discussed where it could go. TM said electric panel comes in the front of the building, so makes the most sense to have it there. Will meet with Clay and Tony to figure out where it goes for sure. Dick said it does cost a lot but fixing the building if it freezes up will cost us more. Motion by Evelyn, 2nd by John to accept price and take from the SB Reserve. 5-0**
- 2. Harbor Committee recommendations-Evelyn went over them, said HC approved events, also discussed the HC proposal for doing a monthly fee for the Pier. Talked several scenarios on the fees, why not put-up boat fees, TM mentioned species fee, less problem with time stickers are up. Travis mentioned fee might not be enough. Board took no action on it and sent it back to them.**
- 3. Clam committee-water quality issues-TM said we had gotten a surprising report from DMR on closing some productive flats on Greenlaw's cove in Deer Isle. A lot of our guys clam there so it has island wide impacts for diggers. TM said she would go to DI Selectmen's meeting and see if they are willing to put in an**

abatement report and TM will see if we can get funds for genetic testing to see what the source of pollution is, animals, human or what.

4. **Playground update**-TM gave progress report, costs, the playground gravel pad is costing more. Really wet this spring, State culvert is too high and will not allow the ballfield to drain better. Board said keep going with it, TM said Cory is going well and the road crew with trying to relevel the ballfield with lumps and holes in it. Screen can stay in place to save money so far. Will keep board informed, playset should be coming in several weeks, plus the installers will let us know when they can come.

5. **Land, Jeff's place and lawn lines, Holt Mill Pond**, -TM said she had contacted Due North about changing the line for the foreclosed house we bid out and sold to Jeff Boyce to fix the line. Also, she asked about the other line behind the building. Nothing on that yet board wants to do. TM talked about the camper and Maxine back and blocking our R/W to Holt Mill Pond and the other problem by Pete Knowlton's for R/W. Do we take to court or fix it or what. Board not decided yet on anything with that.

Old Business-TM said inquiries on Food trucks coming up again. We have no regulation on parking anywhere in town on them other than Selectmen's request to go up to ballfield area and not downtown. Fin and Fern have new carts TM says.

New Business-TM says some people have requested a porta potty at Sand Beach. Board said no, TM said she is glad because we will have campers there with fires which Jean does not want if we make it too comfortable for people. We have enough illegal camping now going on.
