Minutes from March 18, 2024-Motion by Evelyn, 2nd by Travis. 3-0

Weekly Warrants-Motion by Evelyn, 2nd by Travis to approve them. 3-0

1. **Supt Dan Ross- school leg bill concerns/budget**-Dan came in to speak on the budget, up roughly 1.4M on first draft, said they will revisit their numbers and also will utilize at least \$400K in carryover. Talked about police contract and discipline and hate crimes at school with neo nazi kid threats and problems among students and threats and despargments towards teachers and staff.
2. **Fire Dept damage estimate-damage repair approvals**-TM passed out estimate quotes for fixing roof, basement damages, basement overhead door. Motion by Evelyn and 2nd by Travis to start repairs asap from Jan storm damages. 3-0
3. **Sand Beach- lease agreement**-TM said she had spoken to the beach owners now that town meeting had passed the authorization for the yearly lease. The owners do not want kayaks at the beach. It was not the intent at the beginning of the lease 15 years ago and now with the closing of Old Quarry and other places using their beach for commercial activities instead of a beach for families and kids they do not want it anymore. People park for days and also it takes away from parking for families and kids, plus it is causing hard feelings with the neighbors early in the morning and late at night banging kayaks all the time. Wants the town to put up signs prohibiting them as well. Board understands.

4. **Street sweeping contract**-TM said Tim gave a price of \$6500 for all street sweeping, parking lots and cleaning town catch basins. Motion by Evelyn and 2nd by Travis to accept. 3-0
5. **Main Street- culvert problems**-TM said she had contacted DOT about the massive hole from the Pink St brook. Opened up deeper after the other storms again. PW marked it with cones so someone doesn't fall in. TM said she see DOT looking at it.

Old Business-Evelyn said SSD had hard time keeping up with rains on pumps at the last storm.

New Business-TM said she had a request about stand by pay for snow crew going through April instead of ending in March. John asked how much, TM said it isn't that much and beats us shoveling instead of them for the money it would cost or force the PW crew doing OT on it. Motion by Evelyn 2nd by Travis to extend stand by pay. 3-0
TM mentioned ICC had no heat, sent Tony to fix it, Bayview has more sinkholes, will have Andrew look at it for some temp ideas to fix.
