- 1. Andrew McCullough-PowerPoint-Oceanville, Fifield Pt roads, Odd Fellows outreach mtg and projects overview.- Presentation on Oceanville Marsh, Odd Fellows, and Fifield and Sand Beach roads. Information on design draft/concepts, marsh project changed after severe storm to more Army Core design to harden more resilience and using interlocking materials on all projects. 4. **Heating oil bid opening**-Board opened up two bids that TM gave them which had come in. Heanssler Oil had both fixed and tank wagon. RL Greenlaw only had tank wagon. Board decided to go with fixed from Heanssler for \$2.80 a gallon for the 24-25 heating oil season.
5. **Appointment papers/Assessors abatements**-Board signed some abatements for adjustments from factoring.
